


Comments

Frontal impact: the protection offered to the driver's and passenger's head and neck was good. Driver's and passenger's chest showed adequate protection. Driver's and passenger's knees showed marginal protection as they can impact with dangerous structures behind the fascia. Driver's and passenger's left tibias showed good protection, driver's right tibia showed marginal protection, and passenger's right tibia showed adequate protection. Footwell area was rated as unstable. The bodyshell was rated as stable and it is capable of withstanding further loadings.

Side impact: head, abdomen and pelvis showed good protection while chest showed adequate protection.

Side pole impact: was not performed as the vehicle does not offer standard side head protection, resulting in 0 point.

ESC: fitted as standard and the performance shown in the test was acceptable according to Global NCAP's latest requirements.

SBR is standard in all seating positions and meets Global NCAP requirements. All this explains the 2 star result.

Comments

Frontal impact: the child seat for the 3 year old was installed rearward facing using the i-Size anchorages and support leg and it was not able to prevent head exposure during the frontal impact. The child seat for the 18 month old was installed rearward facing using i-Size anchorages and support leg, it showed full protection.

Side impact: the 18 month CRS offered full side impact protection while the 3 year old CRS could not contain the head during the impact.

The car offers 3 point belts in all seating positions as standard. The marking warning consumers about rearward facing CRS in the front passenger position fulfills the requirements but it does not offer the possibility to disconnect the passenger airbag in case a rearward facing CRS will be installed in this position. The CRS installation passed for all seating positions achieving full score. All this explains the 3 star result.
